In order to integrate the gender perspective in the budget processes, the Government of Republic of Macedonia, after the adoption of the 2012-2017 Strategy on Gender Responsive Budgeting, also adopted the Methodology on Gender Responsive Budgeting for the state administration bodies, which shows the process of integration of the gender perspective in the budgeting process.

As part of this activity, a Manual has been prepared for introducing the gender perspective in the programmes and policies, which is available for all civil servants and it provides guidelines on how to make the policies, programmes and activities that are implemented by state administration bodies - gender sensitive, and for them to have the same benefits for all citizens, men and women.
