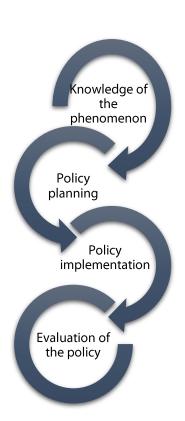

WHY IS ADMINISTRATIVE DATA IMPORTANT?



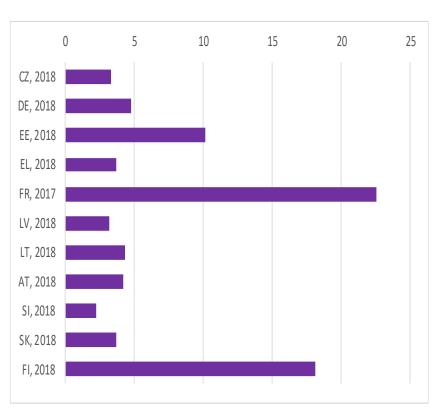
- ✓ Inform policy makers. Assess how public services respond to the needs of women who have experienced violence

- ✓ Monitor trends over time/ between countries
- ✓ Raise awareness

 - ✓ How to contextualize administrative data



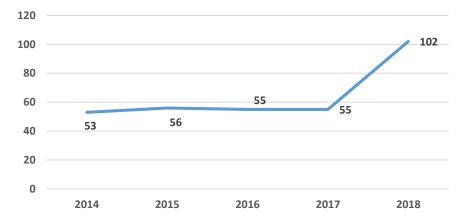


FINDINGS: INDICATOR 8 (RAPE)

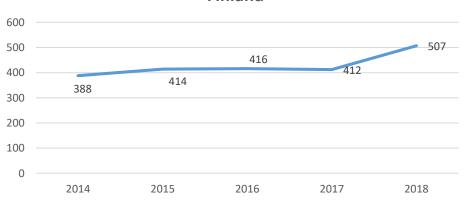
Women victims of rape (aged 18 and over) committed by men (aged 18 and over) with comparable data per 100,000 women population – latest year

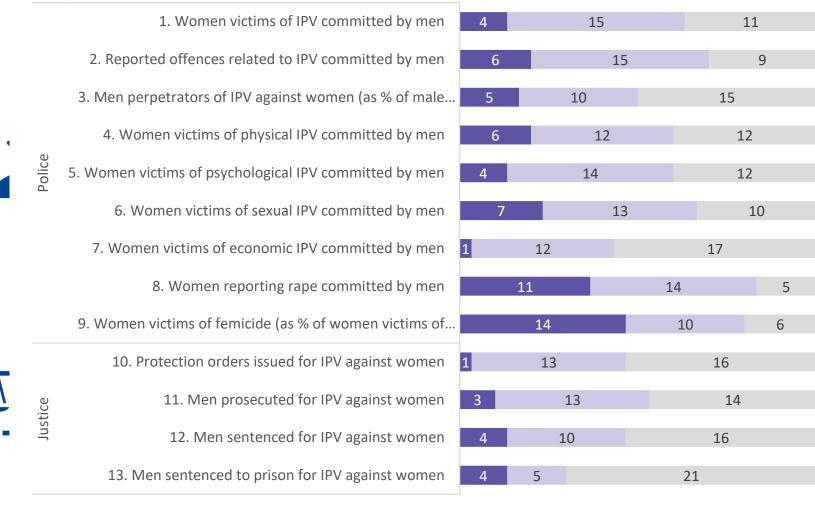
THE EFFECT OF THE 2018 RAPE LAW IN SWEDEN

In Sweden, the legal definition of rape was changed to sex without consent in 2018. This led to a **75% rise in rape conviction rates** over two years, **from 190 convictions in 2017 to 333 in 2019**, as victims were no longer required to prove that 'force' had been used

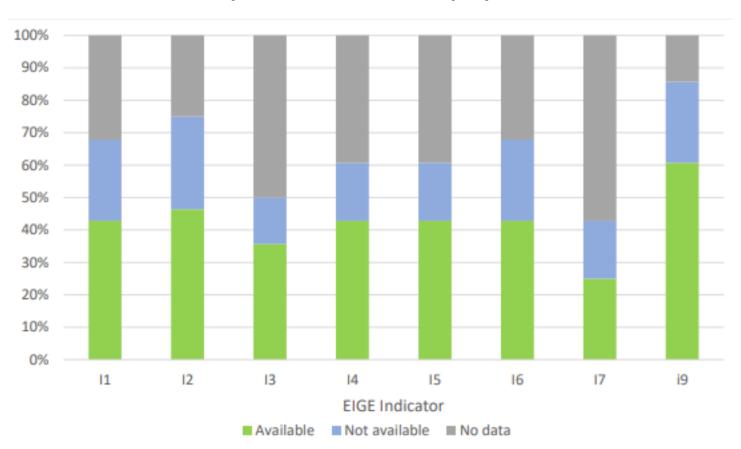

Relationship between victim and perpetrator

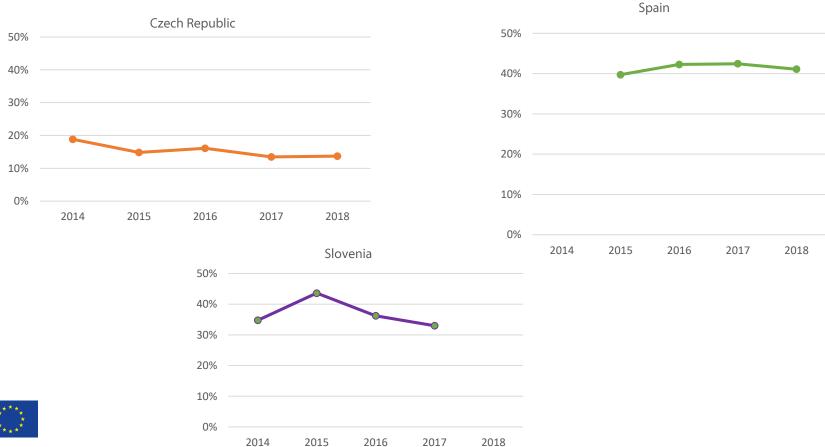






ATTRITION RATES

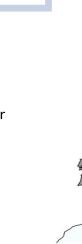

INTIMATE PARTNER VIOLENCE DATA: CHALLENGES

Completeness

Data are quite incomplete, particularly on the indicators based on data from the justice sector. The main reasons include:

- Jurisdictions not recognising intimate partner violence as a legal offence, instead aggregating it as part of domestic violence offences;
- Jurisdictions not systematically recording data on the victims and/or the perpetrator and /or their relationship;
- National data collection systems using different unit of measurement
- No data by victim-perpetrator relationship or for characteristics of both victim and perpetrator

Comparability

The data collection on intimate partner violence chiefly consists of non-comparable data. Differences across Member States may be the result of different legal definitions, different national practices in populating data systems





INTIMATE PARTNER VIOLENCE DATA: RECOMMENDATIONS

Ending VAW must be a key objective of any future framework of EU actions on equality between women and men

- Political commitment towards protecting victims must include measures targeted at ending IPV.
- Approaches to gathering administrative data should be uniformed

Adoption of an EU Directive on all forms of VAW that complements the implementation of the Istanbul Convention

 It could include definitions of different forms of violence and measures for data collection





INTIMATE PARTNER VIOLENCE DATA: RECOMMENDATIONS

Establishing common standards of data collection practices at EU and MS levels

- Display the available data on the sex of the victim and perpetrator across crime statistics' indicators
- Use the ICCS codes for categorising IPV
- Comprehensive guidelines on data collection / Full integration of data collection across the police and justice sector
- Standardise counting units, counting rules. Map relevant offences.
